Monday, September 25, 2017 Fees Committee Meeting Recommendations

NOTE: Recommended overall 4% increase across the board.

Civic Center

- Baseball/Softball field rates: Do a cost analysis of materials (diamond dust, etc.) to make sure we are charging enough.
- Multipurpose Field: Raise price.
- Field lights: Look at electric bills, analyze, and be sure charging enough.
- Banners: Promote heavily and get sales. (Q: Where would they be placed?)
- Pavilion/Amphitheater: Rent and charge for separately. Pavilion, same price as Medalie's (\$52 for four hours), plus 4% increase, like Medalie's will be increased. Fees Committee wants to charge for electricity at pavilion every time. Amphitheater, charge \$32 for 4 hours.
- Make sure we are charging enough (\$32) for staff labor at Civic Center, and enough (\$13) for "Additional Cost/Hour for Setup by Customers."
- Should we set a storage fee and a package delivery acceptance fee officially for shows and such?

More Revenue-generating Suggestions for Civic Center

- New concessions vendor. (RFP in January)
- Clean out or tear down Pugsley building.
- Clean out old probate court building and rent.
- Clean up and paint pavilion.
- Raise Norte's rent from \$250 to \$300 per month.
- Outdoor pickleball courts on former playground site.

Medalie Park

Twin Lakes Park

- Cleaning Cost for Dorm Stays Long than Two Nights: raise from \$25 to \$35 per additional day
- Delete "Use of Gilbert Lodge Incubator Kitchen per Hour/Per Month by Chefs"
- Delete rental of kitchen and combine it with rental of lodge very time. Market it with kitchen. Please talk with Ariel and me on Monday and we will explain our plan for this.

More Revenue-generating Suggestions for Twin Lakes Park

Hire event/rental manager and share revenue.

Clean out cabins and charge at least \$100 per one night's stay (Ariel has done research on this; will share Monday).

Rent Caretaker's Cottage until spring for \$400 per month and a good pair of eyes.

Rent Caretaker's Cottage from May 31 through October 31 like the other two cottages.

Revenue-generating Suggestion for Keystone-Birmley Property: Look into selling topsoil.

Power Island

Firewood: 7 per bundle

Exclusive rental of one or both islands: \$50 extra surcharge per night; maximum of three nights.

More Revenue-generating Suggestions for Power Island

Build the two cottages in spring for rent during camping season; rent at market rate.

Subject: **Policy 2011- 03 - User Agreements**

It is agreed that the Parks and Recreation Department has a diverse number of agreements with several different user groups at its property. It is also evident that our user groups provide different challenges related to their needs, and the needs they have of our properties and facilities. In an attempt to streamline the process, and provide some consistency to the diverse groups, it is suggested they each be categorized into groups for more efficient administration of user agreements.

Each group would have its own unique user agreement that is similar in format to other users that fit within the same category. Each category of agreements would receive final approval from different levels of our organization, and each would have different requirement for provision of insurance for their events.

The Parks and Recreation Director has the authority to determine the group a user fits within.

The groups would be categorized as follows:

Management Group - This group is designated as a Management Group due to the more robust agreements that typically would be associated with management of an entire park, or facility. ---
- These agreements would typically (but not exclusively) be longer than five years, and would allow the groups to either have exclusive use, or primary use of the facility.
- In all cases, the user groups would have to include Grand Traverse County as an additional insured for \$1,000,000.00.
- Agreements at this level would require the approval of the **Parks and Recreation Commission**. This agreement group would include TBAYS and I.C.E.

Steward Group - This group is designated as a Steward Group, due to their role as being a steward in promoting the positive use of our facilities or parks.
- These groups would typically work with Parks and Recreation to schedule regular events, with maintenance and upkeep of facilities and parks performed by Grand Traverse County.
- These agreements would typically be one-year agreements or less.
- This group would have exclusive use of a park or facility during a pre-determined set of times, but would not prevent any other user groups from utilizing the facility or park during times not scheduled.
- In most cases, the user groups would have to include Grand Traverse County as an additional insured for \$1,000,000.00.
- Agreements at this level would be approved by the **Parks and Recreation Director**.
- This agreement group would include YMCA softball, Breakers Swim Team, and the TBA Swimming Program. This group would be where tournament and more complex shorter term

events would be including, the hunting and fishing Show, the boat show, softball tournaments, video game (LAN) parties, and hobby shows.

Individual Group - This category typically will be made up of individuals, but may include small organizations or groups, that are interested in utilizing our facilities and park for infrequent, irregular, or one-time events.

- Entities in this category may be interested in renting our facilities for a one time event, such as a meeting, small party at a pavilion, campsites, or a one-time rental of Twin Lakes.
- The maintenance and any set up/tear down will be included with the daily duties of Grand Traverse County.
- The agreements in this case would provide exclusive use of the area/facilities rented during the time specified on the permit.
- In very few cases we require Grand Traverse County being named an additional insured.
- These functions are typically lower risk events.
- Agreements at this level would be approved by **Parks and Recreation Staff** members via a tentative/final permitting system within our registration software.
- This agreement group will include the users of our pavilions, campsites on Power Island, and birthday party rentals within Easling Pool.
