PUBLIC INPUT: About Public Input

Democracy happens when “We the People” have a voice in making decisions about all matters that determine the relations between “We the People”.

Good democracy can only happen when the voices of “We the People” are heard by those individuals who were elected by “We the People” to be representatives of “We the People”, and entrusted with some power we allow them to rule over us. Government “by the people” is thus the basis of democracy.

Until a few weeks ago, Grand Traverse County used to acknowledge statements made during public input by stating in the meeting minutes the subject matter of each comment made, and sometimes if the presenter was “for” or “against” some proposed action. Now, the minutes only report a list of names under public comment. The gist of this seems to be: “We the People” have not been heard. Or, you of the commission are afraid to acknowledge there is public sentiment, and public knowledge that contradicts what you know to be true.

Good government depends on well informed people, using valid information to justify any decision they make. “We the People” do not like expanding secrecy and deception.

Public Input: **Employment Contract Auto-Insurance Liability**

Any attempt by a person of average intelligence to understand the Michigan automobile insurance program, and the Personal Injury Protection, the “PIP” clauses contained therein, will likely go away even more confused and frustrated. Almost everything that the current legislature has added to the Act makes the entire document worse. Aside from the synopsis provided by the invested parties touting the reforms as an improvement, the realistic take-way is there is now a five-tier system that divides citizens into economic classes that determine their potential financial and medical risk futures.

Grand Traverse County recognizes the liability that commences when a contract is written where one party assumes an obligation to perform service for another, which is why the County requires contractors like *Independence Home Health Care* to provide certificates proving they carry both “general liability” insurance and “Workers Compensation” insurance covering their company and their employees.


Last week Michigan changed from a system of “No-Fault Auto Insurance” with unlimited personal injury protection that applied equally to automobile owners, drivers, passengers and even pedestrians involved in an automobile accident. Those days are gone and now it is time to start writing contracts that ensure the County does not get caught in lawsuits where injury judgments could easily dwarf our total retirement obligations.

Anyone who drives a vehicle as an employee of the County is now individually at risk for their own injury and any injury they may contribute to causing. If they have a minimal policy, after their basic coverage runs out, the courts will come after their personal assets, then they will go after the deepest pockets connected to the liable party. That may be a plow truck in the winter, a building inspector, or a county clerk driving to a polling precinct, or a commissioner going to a meeting where they are paid a per diem and travel expenses.

As new agreements are drafted, this county should expect to pay more by requiring all contractors and all employees to have maximum personal injury protection that provides at least as much as we used to have in Michigan. It is the same old axiom of: “We can pay now or pay a lot more later, but we will pay eventually.”

We should be prepared to pay the consequences, because now it is “Your-Fault Auto Insurance”, or perhaps someone else’s fault, depending on who can afford the better lawyer.
