The Grand Traverse County Health Department (GTCHD) continues to partner with community agencies and mobilize outreach clinics throughout the county to make the COVID-19 vaccine more accessible for all. In an effort to reach and hopefully surpass the State of Michigan's goal of 70% vaccinated in our county, the following locations, dates, and times will offer walk-in availability for the COVID-19 vaccine.

Any child that 12 to 15-years-old must be accompanied by a parent or guardian. Verification of date of birth is required.

Anyone 16 to 17-year-old, must have a parent or guardian fill out a [minor consent form](#) and a [vaccination administration record form](#) for the minor to bring with them to the clinic.

As of May 14, 42.1% of all Grand Traverse County residents aged 12 years or older have completed COVID-19 vaccination (two doses of the Pfizer or Moderna vaccine or one dose of the Johnson & Johnson vaccine). And 64% have received at least one or more doses of any of the COVID-19 vaccines.
