Moving into the 45th year of Probate and Family Court Volunteer Services, we are proud to grow and support the needs of our courts and our community. Our team is dedicated to providing assistance to Probate and Family Court, including the Juvenile Probation Department. Our mission is to recruit and support volunteers with on-going training, enrichment and recognition.

*We started off 2015 by celebrating the 33 years of hard work and dedication that is Linda Fawcett, wishing her farewell in her retirement.

*RDSS Training– Volunteer Services boasts 17 RDSS (Regional Detention Support Services) trained transporters thanks to a training this past fall at the Grand Traverse Resort.

*Learning Partner Events– Learning Partner Volunteers and their students experienced a variety of activities together throughout 2015; Northwest Michigan Fair, hiking, ice skating, swimming lessons, and a back to school picnic. All of these events occurred in conjunction with the weekly one on one contact between youth and their Learning Partners during school hours.

*CASA Program-22 volunteers advocated for 53 children involved in neglect/abuse cases in 2015.

*CASA training– The CASA Program trained 10 new volunteers over the course of 30+ hours of classes facilitated by Volunteer Services and community agency staff.

*New transport car– Thanks to Sgt. Roy Raska, Volunteer Services was able to acquire a “new to us” transport car to replace an aging vehicle.

*Survey assistance– Thank you to the many volunteers who assisted in the distribution of customer satisfaction surveys for District, Family and Probate Courts this past fall.

*Orientation of new volunteers– 12 new volunteers were orientated to Probate and Family Court this fall. Attendees participated in two evenings of informational meetings about court process, programming, and volunteer experiences.

*Volunteer Services transitioned the newsletter to a digital format in 2015, reducing cost and paper waste for the department.

*For the 8th consecutive summer, New Vision Academy provided youth on probation with experiential opportunities. These sessions were provided by multiple community volunteers facilitating on a variety of topics.

*Volunteer Services dusted off the sewing machines and welcomed two new volunteers, eager to lead a community service work project for youth on probation. Thank you, Laura Scott and Karen Mauro-Doren!

Exciting new changes are happening with the Learning Partners Program. The youth that Learning Partners are currently assigned to will continue to work with that child. However, research tells us that children in our elementary schools at greatest risk of leaning issues are many times children who are court involved or have an immediate family member court involved. Learning Partners, since it is a program within the Family Division of the Court, offers the perfect opportunity to provide support for these children. Since there is such a great need, Learning Partners moving forward will only be working with children who are court involved (neglect/abuse case children, foster care children) or have an immediate family member court involved (parent in jail, sibling on probation, etc.).

Simply, previously matched volunteers will continue with their assigned match. New Learning Partner matches will be with children court involved or children who have an immediate family member court involved.
