On Tuesday, **January 20, 2015**, at 4 p.m., Learning Partners will join

CASA volunteers, to hear from **Heather Prevo, Truancy Intervention Program Coordinator**.

She will discuss the Michigan School-Justice Partnership and how truancy is being addressed in Grand Traverse County. Heather will discuss how this program works with the schools to monitor and respond to children who have lack of attendance issues at school.

Success for children is often linked to regular school attendance. Kids who are not in school are often linked to those who find themselves later in life, in jail. "Pipeline to Prison" is a phrase most recently used to describe this problem.

CASA volunteers and Learning Partners are directly involved with children who fall into these at-risk categories. Learning Partners are an early elementary intervention program established to prevent youth from becoming court involved. CASA volunteers advocate for children in foster care who have been removed from home due to neglect and or abuse. Statistics show that 25% children in foster care will find themselves, in jail, as older youth or adults.

Please join us for this important and timely meeting.

On Tues., **February 17th, 2015**, **Sue Greenfelder, DHS, Education Coordinator** will be present to tell CASA volunteers how youth in foster care are supported during school and after high school graduation.

## Story of Hope From a CASA Volunteer

Megan was a girl in foster care, when I decided to take her case as a Court Appointed Special Advocate. As her CASA volunteer, I would meet with her regularly to gain personal knowledge of her and her situation, understand her wishes, and look out for her best interests: a safe, permanent home, as soon as possible. Megan was living in a foster care home that had turned out to be a poor fit for a teenage girl. At 14, she was scared, and lived a pretty unstable life with a mom with severe mental health issues, and a father who was never in her life. After many visits, and much sushi, Megan began to trust me. Working with agency workers we were able to move her to a different foster care home.

Her parents released their rights to her and it turned out that the new foster care home was also interested in adopting her. Her new parents lived in town and Megan flourished in school, taking advantage of dual enrollment with NMC. During this time our relationship grew and a healthy, joyful, young lady began to emerge.

Upon closing of her case, she was accepted as an exchange student overseas. She has also spent time abroad attending the American University. After returning to Traverse City, we reconnected and she is now recognized in my household as, "part of the family". She is full of confidence and has a smile that can light up a room. Her future is bright and she makes me very proud. As her CASA volunteer, I know I played a part in helping her become the young woman I see today.

There is hope out there—I am so glad I was around to help her in her journey.

Diversion Program. The purpose of the "exit", is to find out how the program was helpful (or not) and what we might do to improve it.

The youth in this matter stated; *"I feel more confident and I feel proud of myself."* Also, *"I feel I was allowed a second chance and now I have a clean slate. It was good for me, now its over and I'm very thankful"*. The parent in this case stated; *"This was a positive, reinforcing experience giving us all a positive outlook on the future. She understands that negative-unlawful behaviors have serious lasting consequences. I think this is a great program and opportunity for kids who deserve a second chance."*
