**GTCHD weekly outreach clinics schedule**  
**May 10 - 14**

While Northwest Michigan College's Hagerty Center has served as the primary vaccination clinic site in Grand Traverse County over the last four months, the Grand Traverse County Health Department (GTCHD) continues to partner with community agencies and mobilize outreach clinics throughout the county to make the COVID-19 vaccine more accessible for all.

In an effort to reach and hopefully surpass the State of Michigan's goal of 70% vaccinated in our county, the following locations, dates, and times will offer walk-in availability for the COVID-19 vaccine.

**For the week of May 10 - 14, 2021, the following locations will be:**

**Date:** Wednesday, May 12

**Clinic Location:** NMC's Hagerty Center (715 E. Front Street Traverse City, MI)

**Time:** 9 a.m. - 4 p.m.

**Vaccine offered:** Johnson & Johnson (18 and older) and Pfizer (**16 and older**) – second Pfizer dose will be administered at GTCHD's Cherryland Mall Site (1700 South Garfield Rd. Traverse City, MI 49686)

**Date:** Thursday, May 13

**Clinic Location:** NMC's Hagerty Center (715 E. Front Street Traverse City, MI)

**Time:** 12:30 p.m. - 4 p.m.

**Vaccine offered:** Johnson & Johnson (18 and older)

**Date:** Friday, May 14

**Clinic Location:** Workshop Brewing Company (221 Garland St, Traverse City, MI 49684)

**Time:** 1 - 4 p.m.

**Vaccine offered:** Johnson & Johnson (18 and older) and Pfizer (**16 and older**) – second Pfizer dose will be administered at GTCHD's Cherryland Mall Site (1700 South Garfield Rd. Traverse City, MI 49686)

**For the above dates, we can only accommodate those interested in the vaccine that are 16 and older. The Advisory Committee on Immunization Practices (ACIP) is scheduled to meet and vote on approval to expand the age range for the Pfizer vaccine to 12-15 year olds on Wednesday, May 12, 2021. When and if approved, the GTCHD will then begin planning for clinics dedicated for that age range.**

As of May 10, 54.9% percent of all Grand Traverse County residents aged 16 years or older have completed COVID-19 vaccination (two doses of the Pfizer or Moderna vaccine or one dose of the Johnson & Johnson vaccine). And 63.4 have received at least one or more doses of any of the COVID-19 vaccines. We need everyone to do their part to protect those that cannot get vaccinated yet - children under 16 and those who are immunocompromised.
