<b>MDOT</b>	<p>Political candidates are responsible for obtaining approval from the adjacent property owner to place the signs. Signs must be removed w/in 10 days following election. Signs must be more than 30 ft from the edge of the roadway (white line) for highways that do not have barrier-type curbs. For highways with barrier curbs, the signs must be more than 3 ft from the back of the curb. Signs are not permitted w/in areas used for clear vision at intersections or commercial driveways, so they will not interfere with the sight distance of a driver. No signs may be placed within the limited access rights-of-way. Any illegally placed signs will be removed.</p>
