



CURRENT NUMBERS AND TRENDS

Grand Traverse County is reporting out on 56 newly identified cases over the last week. Our 7-day case average is now 8 cases per day, compared to <1 at the beginning of July. As of Thursday, July 29, there are currently 116 active cases in the county.

GTCHD OFFERING ALL THREE COVID-19 VACCINES AT CHERRYLAND LOCATION

The GTCHD is now offering the Moderna COVID-19 vaccine at its Cherryland Center location in addition to Pfizer and Johnson and Johnson (J&J) vaccines. This provides the most flexibility for those seeking COVID-19 vaccination, whether it is a first dose, second dose, or both.

GTCHD VACCINATION CLINIC SCHEDULE

GTCHD CONTINUES TO EXTEND *FREE* COVID-19 TESTING AVAILABILITY

The Grand Traverse County Health Department (GTCHD) continues to offer **FREE** COVID-19 testing availability at its main campus.

Vaccinated or not, if you are experiencing symptoms, even minor ones, (cough, shortness of breath, fever, chills, nausea, fatigue, headache, sore throat, congestion, diarrhea, vomiting), please seek testing. If you are vaccinated, you may experience more subtle symptoms, but getting tested is the best way to know if it's COVID or not.

Hours for the week of August 2-6:

Monday, Wednesday & Friday from 9 a.m. - 12:00 p.m. and 1 - 4:00 p.m

Location: 2600 LaFranier Rd. Traverse City, MI, 49686

- Testing is available to anyone regardless of symptoms and is done on a drive-up basis only.
- **Testing is drive-up** (no appointment necessary) and will be done **in the parking lot behind the main health department building**.
- A doctor's order is not needed and there is no charge to be tested.
- Anyone that tests positive or is symptomatic will be offered a PCR (polymerase chain reaction) test following the rapid antigen test. Tests are for diagnostic purposes (this is not an antibody test).
- Results will be delivered electronically (email/text) within two hours.

Grand Traverse County continues to have the 2nd highest vaccination rate in Michigan. Neighboring Leelanau County has the highest rate. Vaccination coverage rates for Grand Traverse County residents of the 12+ population:

69.4% initiation

65.6% % completion
