1. Welcome
County Administrator Nate Alger spoke to the members regarding the county operation funding.
2. Project Criteria and Priorities
Tim Dempsey reviewed investment criteria and expenditure priority criteria for the members. The previous sessions investment criteria was summarized prior to a discussion of overlapping concerns across sectors.
