Day 1: Wednesday, August 2, 2023 Fairbanks, Alaska - Tour Begins Your tour opens in Fairbanks,* in the great state of Alaska, on an adventure that brings together the best of both land and sea.

Day 2: Thursday, August 3, 2023 Fairbanks - Denali National Park Step aboard the popular Sternwheeler Discovery, an unforgettable journey showcasing Alaska’s diverse culture and rich history. Make stops along the way to meet the people and get a taste of local life. Take a scenic motor coach ride to Denali National Park. Tonight, enjoy a musical performance that tells the story of the first brave men to summit Denali followed by dinner. *(B, L, D)*

Day 3: Friday, August 4, 2023 Denali National Park This morning, travel deep into Denali National Park on the Tundra Wilderness Tour** which affords the best opportunities to view the region’s wildlife. IDENTIFICATION

Travel within USA

For travel completed by May 2, 2023, all airlines will ask for identification when you check in. It is recommended that you carry a passport if you have one. A driver's license (with a photo I.D.) is also acceptable for domestic flights.

Effective for travel May 3, 2023 forward, the REAL ID Act standards for identification while travelling will be in effect. This means a standard issued driver's license used as a form of identification will no longer be accepted for domestic air travel within the United States. Instead, a Real ID compliant form of identification must be presented both at the time of booking air travel with Collette and upon checking in at the airport to board any flight. Any fees associated with changing a reservation resulting from a non-compliant identification will be the responsibility of the guest. IDENTIFICATION

Passports are required for this tour at your expense. Certain countries require a minimum of 6 months passport validity from date of return home. You are strongly urged to contact the appropriate consulate for details. Visit www.travel.state.gov for the U.S. State Department for the latest details about passports and visa requirements.

IMPORTANT: We recommend that our clients traveling abroad take a photocopy of their passport and applicable visas. It should be packed separately from your actual passport and visa. We also recommend leaving a copy at home with your emergency contact.

Port taxes and fees starting from \$649 USD per person, quoted at time of reservation, are included in the tour cost. Single cabins, if confirmed, are higher.

Some attractions may not be available during the off-season months. This is reflected in the price of your tour.

Triple accommodations are limited and will be confirmed upon request and availability from the cruise line.

Order of ports may be changed by the cruise line.

Cruise ships have a limited quantity of cabins available in each cabin category. We will make every effort to accommodate your cabin category preference at the time of booking. If the cabin category preferred is not available at the time of booking, the next closest category available will be offered and a surcharge may apply.

To complete your tour, we include roundtrip airport-to-hotel transfers when purchasing our airfare with your tour. If you have arranged for your own air, we are pleased to provide you the option of purchasing these transfers. Please note that all transfers will leave at pre-scheduled times.

Single accommodations are limited and are available on a first come, first served basis.

*Accommodations in Fairbanks will be assigned prior to departure.

**The Tundra Wilderness tour is a fully narrated 5-hour tour. During the early season on departure dates before May 20th, this tour will be replaced with the 4-hour Denali Natural History Tour.

The overall activity level of this tour is a level 1. This means you're a leisurely traveler. You like to discover the energy of a new place, but typically take it easy. You can handle at least one flight of stairs, board a coach, and walk for 15-30 minutes at a time with little difficulty.

Prior to full payment for the program, the cruise line reserves the right to impose a supplemental fuel charge. Should this occur, you will be notified of the additional charges.

Please be advised many airlines do not provide advance seat assignments until check-in at the airport. Advance seating will be subject to the airline's terms and conditions.

This cruise has ports of call in Canada; therefore, a **passport** is required.

Onboard gratuities are not included in the price of your tour. For your convenience, Holland America Cruise Lines automatically applies a 15.50 USD, quoted at time of printing, per guest per day service charge to your shipboard account. All of the service personnel on board receive gratuities from this service charge and there is no need for you to think about additional tipping. Separately, a 18% gratuity is added for bar drinks and spa services.

Most flights arrive into Fairbanks very late at night followed by an early morning the next day.

Due to tour scheduling, return flights should not be booked prior to 12:00 noon.

Economy air rate and schedule are applicable for groups of 10 or more traveling on the same flights and dates.

A deposit of \$898 per person is due upon reservation. Reservations are made on a first come, first served basis. Reservations made after the deposit due date of January 26, 2023 are based upon availability. Final payment due by April 04, 2023. Deposits are refundable up until February 02, 2023.
