

Keystone Soccer Complex

Use Rules and Regulations

The following are the rules and regulations of Keystone Soccer Complex (the "Park") which is a Grand Traverse County Park under the control of the Grand Traverse County Parks and Recreation Commission ("GTCPRC"), managed and operated by Traverse Bay Area Youth Soccer, Inc. ("TBAYS"), as approved by the Grand Traverse County Board of Commissioners:

1. Visitors shall park in designated areas only.
2. The use of unauthorized motor vehicles on maintained grounds, including all fields and pathways is prohibited. The term "motor vehicle" includes, but is not limited to, automobiles, motorcycles, mopeds, motorized scooters and skateboards, motorized bicycles, golf carts, snowmobiles, snowbikes and any other vehicle capable of being self-propelled. Persons with a qualified disability, as defined in the Persons with Disabilities Civil Rights Act (PWDCRA), MCL § 37.1101, *et seq.*, and the Americans with Disabilities Act (ADA), 42 USC 12101, *et seq.*, are exempt from this rule when using an electric wheelchair, electric powered scooter or similar device necessary to provide mobility.
3. No person shall bring into to the Park any trash, refuse or other items with the intent to deposit, throw away, dump, or otherwise leave at the Park in any trash receptacles, bins or dumpsters. Additionally, any litter, refuse, rubbish, trash, or garbage resulting from the use of the Park shall be disposed of in receptacles, bins, and dumpsters located in the Park.
4. Open fires, including barbecue grills or other devices used for cooking, are prohibited except with the express written permission of TBAYS or by authorized concessionaires.
5. The use of excessively wet fields as determined by TBAYS or where water is present, where doing so is likely to cause damage to turf, is prohibited whether or not notice of field closure is posted.
6. It is prohibited to place or erect a fence or barrier, to construct or occupy improvements, to construct or erect a deer blind, or to enclose the lands or obstruct the passage of another person or persons in any way from entering, exiting, or using Park property without permission of TBAYS.
7. It is prohibited to peddle or systematically solicit business of any nature, to distribute or post any handbills or other advertising matter, or to post signs, without permission of TBAYS.
8. It is prohibited to paint, mark, or otherwise apply any chemical or harmful substance on any tree, rock, or any other land, water, structure, or property without permission from TBAYS.
9. Dogs and other pets are prohibited in or on all fields and parking areas. Dogs and other pets in other areas must be on leash at all time. This rule does not apply to service animals except

that they too must be on a leash.

10. No person shall ride or lead a horse or other member of the equine family, pack animal, or other riding animal, or any animal- driven vehicle, on any area within the Park.
11. Activities that interfere with the primary use and design of the Keystone Soccer Complex, including, but not limited to, golf, the use of radio-controlled aircraft, and rockets, are prohibited.
12. Use or possession of alcoholic beverages is prohibited except when specifically authorized by TBAYS Board of Directors and the Parks Director. The use of illegal substances anywhere within the Keystone Soccer Complex is prohibited.
13. Keystone Soccer Complex is a non-smoking park. The use of tobacco or to smoke within the Keystone Soccer Complex is prohibited. This includes smoking cigarettes, cigars, pipes, e-cigarettes, vaping, and any other smoking device or substance. Further the use of marijuana in any form is prohibited within the Keystone Soccer Complex.
14. The use of or discharge of firearms, weapons, or explosives of any kind is strictly prohibited anywhere on or about the Keystone Soccer Complex.
15. Goals and field markers shall not be moved except by authorized TBAYS personnel.
16. Public use of fields. Members of the public may use the fields when not otherwise scheduled by TBAYS under the following rules:
 - a. Organized groups. Organized groups are permitted to use fields only with the express written authorization of TBAYS and may be subject to certain fees for such use and other terms and conditions as required by TBAYS. The term "organized" as used in this rule means a group of Ten (10) or more, that meets one of the following conditions:
 - i. The group meets more than once per week; or
 - ii. The group charges a fee to its participants or its participants pay any amounts relative to the Group; or
 - iii. The group is part of a league, or other similar entity;
 - b. Non-organized groups or individuals. Non-organized groups or individuals may use the fields when not otherwise scheduled for play or practice by TBAYS.
 - c. TBAYS may close any or all fields to public use when necessary for field maintenance or to promote field growth and/or recovery, due to weather conditions that may result in damage to fields from use, for safety purposes or for any other reason which is intended to improve the park and its condition.

17. TBAYS shall have the right to close roadways within the Park to motor vehicles, with permission of GTCPRC. All persons shall abide by any roadway closures and shall not attempt to circumvent any barriers closing such roadways in order to gain access to the Park.
18. An individual or group who fails to obey any of the above rules may be requested to leave the facility without further warning. An individual or group who violates any of the above rules after being informed of the violation, or after having been previously requested to leave the facility due to a prior violation, may be banned from the facility for a period to be determined by TBAYS.
19. TBAYS shall have the right at any time to ask any player, spectator or visitor to the Keystone Soccer Complex who is disruptive, showing signs of violent behavior, aggression or who is displaying unruly or uncivil behavior, to leave the field area of the Complex. Any said person or persons failing to abide by such request shall be in violation of these Rules.
20. No person shall refuse to comply with the above rules upon the demand of an authorized local TBAYS official or other local official, or to interfere with the official's enforcement of these Rules and Regulations, or to retaliate against another who has made complaint of a violation of Park Rules and Regulations; or, to interfere with an employee or agent of TBAYS while performing his or her official duties.
21. These rules may be enforced by all TBAYS staff. The Grand Traverse County Sheriff is granted authority to assist in enforcing violations of these rules.
22. Fines and Imprisonment. Any person violating any provision of the foregoing rules shall be deemed guilty of a misdemeanor and upon conviction thereof shall be fined not more than \$100 and costs of prosecution or imprisoned in the Grand Traverse County Jail for a period not exceeding 90 days or both, for each offense.
23. Compliance with Other Laws. Nothing in this ordinance impairs or precludes a separate cause of action provided by statute or common law for conduct prohibited herein.
24. Severability. The provisions of this ordinance are severable and if any part is declared void or unenforceable by a court of competent jurisdiction, the remaining parts shall remain in force.
