

2026 TRANSPORTATION ASSISTANCE

Transportation vouchers and BATA bus passes are available from the COA at a discounted rate based on client household income (see the sliding fee scale on the back of this sheet).

The approved vendors listed below will accept transportation vouchers for payment. Please contact vendors directly to schedule a taxi ride.

Identification must be shown to vendor upon request.

All vouchers and BATA bus passes must be paid for in advance if client does not qualify for free transportation.

Transportation Vouchers

- Charges range from free to \$38.00 per packet, refer to the sliding fee scale.
- 1 set of vouchers per client per month are available (equal to \$120) OR 3 sets of vouchers per client per quarter (equal to \$360).
- Each set contains 24 vouchers valued at \$5.00 each.
- Vouchers expire Dec. 31st each year.

BATA Bus Passes

- Charges range from free to \$28.00 per pass, refer to the sliding fee scale.
- 12 passes per client per year are available. Limit of 1 pass per month.
- Market value of 1 pass is \$33.75.
- BATA bus passes do not have an expiration date.
