

This analysis shows that the County's largest taxpayers are a relatively stable, yet a diverse group, with six firms appearing on both lists (2001 and 2011). The County's broad tax base results in a minimal dependence on large taxpayers.

The top ten taxpayers currently provide 3.36% of the total 2011 taxable value.
